



WARRANTY CERTIFICATE

Subject to the General Terms and Conditions of the Sale, Seller warrants to the Buyer that for a period of one (1) year from the date of Delivery (meaning the date of Delivery of the product to a carrier at Seller's address), the product will be free from defects in title, material, and workmanship, or until the product is first operated (first flight) for normal commercial use, whichever occurs first.

"Normal commercial use" as that phrase is used herein means the use of the product (i) in a manner and for the purpose for which it was designed and purchased (ii) first flight and (iii) in accordance with the manufacturer's specifications and limitations.

Any alteration, modification or bench testing of the product by any person other than Seller or use of the product in an improper manner will render this warranty null and void. Seller neither expresses nor implies any warranty at all with respect to any product once no longer owned by Buyer, any product sold which after its purchase from the Seller is repaired or altered without Seller's consent of the method used, and wear and tear of parts or materials within the warranty period specified above.

Other than as described above, Seller makes no other representations and/or warranties, either express or implied, regarding the final product, including without limitation, any warranties as to merchantability, quality, or fitness for a particular purpose, and any warranties not set forth herein are expressly disclaimed.

Seller shall not be liable in any way whatsoever for special, indirect, consequential, punitive or incidental damages, whether based on breach of contract, breach of warranty, tort (including negligence), product liability or otherwise, even if they have been advised of the possibility of such damages.

Buyer agrees that his or her amount of damages of any type against Seller for any liability, claims, or damages, owed by Seller, if any, shall be limited to a maximum amount equal to only the purchase price of the individual faulty parts and irrevocably waives all claims for any other damages that such user may have in excess of the same.

This Sale shall be governed by and construed and enforced in accordance with the laws of the State of Colorado. By executing this Sale all parties stipulate that the sole venue for any litigation brought to construe the terms of or enforce this Sale or any arbitration award issued pursuant hereto shall be in the District Court of Boulder, Colorado. Buyer hereby waives the right to trial by jury in any action or proceeding based upon, arising out of, or in any way relating to this Sale or any conduct, acts, or omissions of Seller or any of their directors, officers, employees, agents, attorneys, or any other persons affiliated with Seller, in all of the foregoing cases, whether sounding in contract or tort or otherwise.
